Jay,

As discussed at our recent meeting, following our hearing, we think it would be beneficial to all of us if we could extend our continuance to be slated for Sept rather than August to give us additional time to explore options for addressing the concerns stated at the July hearing. As we referenced, we are designing new custom floor plans and elevations for this project. From the comments we've received from the commissioners, we are in the process of modifying the floor plans (reducing overall footprints where possible) to use more traditional setbacks as well as further developing the elevations to give a better picture of our goal of a 'quaint southern street'. We are also looking to see if it's possible to reduce the number of lots to decrease density, allow more space between the houses and still keep the project financially viable. These are not quick simple changes and will take more time than can properly be done by the August hearing. We would like to have time to adequately explore options to address the concerns, and thus respectfully request our continuance be extended to September.

I'll be happy to discuss this with you if needed, or helpful and as discussed, and if needed, we will be at the August meeting for this continuance request to be presented.
